The Martin City Council met in Regular Session on Monday, December 19th, 2022 at 5:30 p.m. in the city office at 101 Main Street.

Mayor Gary Rayhill called the meeting to order with council members, Tootie Moffitt, Gloria Claussen, Gregg Claussen, Lindsee Harris, Kevin Rascher and Jay Yohner present. Absent, none.

Others present were Marj Frew with the Bennett Co Booster, Ernest Libby, Robert Fogg, BC States Attorney Sara Harris, Police Chief Brandon Petersen, City Foreman Paul Noel, and Finance Officer Jean Kirk.

Approval of Agenda: Yohner moved to approve the agenda with flexibility. Gloria Claussen seconded the motion. All in favor, motion carried.

Minutes: Gloria Claussen moved to approve the November 14th minutes. Harris seconded the motion, all voting aye, motion carried.

Finance Officer's Report: Gregg Claussen moved approve the Finance officer's report for November. Seconded by Moffitt, all voting aye, motion carried.

Yohner entered a motion to give Mr. Libby a six-month extension on the abatement. Gloria Claussen seconded the motion, all voting aye, motion carried.

Rascher entered a motion to remove the property at 909 Far Vu off the abatement list. Yohner seconded the motion, all voting aye, motion carried.

Law: There were 127 total events for November with 127 calls for service and 7 arrests, 2 of those being felony arrests. Officer Skylar Faubion is at the academy and has two months left to go. Rascher moved to go into executive session concerning personnel SDCL (1-25-2.1) with council, mayor, police chief, and finance officer. Into executive session at 5:45 p.m. out of executive session at 5:59 p.m. No action taken

Election: Rascher moved to combine the city election with the school's election in April. Yohner seconded the motion, all voting aye, motion carried.

Ice Rink: A discussion was entered on putting an ice rink in at the sand volleyball court. Rascher moved to purchase a tarp and try to get an ice rink in on the sand volleyball court. Moffitt seconded the motion, all voting aye, motion carried.

Markota: Yohner moved to have the city fix the ceiling fans at Markota. Harris seconded the motion, all voting aye, motion carried.

Write offs: Yohner moved to approve the list of write-offs presented by the finance officer. Rascher seconded the motion, all voting aye, motion carried.

Speed Limit Ordinance #246: The second reading of Ordinance #246 was held.

AN ORDINANCE AMENDING SECTION 27 GENERAL MOTOR VEHICLE SPEED LIMITS. TO MARTIN CITY CODE TITLE FOUR CHAPTER ONE

BE IT ORDAINED BY THE CITY COUNCIL OF MARTIN, BENNETT COUNTY, SOUTH DAKOTA:

That Martin Code 4-1-27 be amended to read as follows:

4-1-27 GENERAL MOTOR VEHICLE SPEED LIMITS

Published 12/28/22

It shall be unlawful for any person to operate a vehicle upon the streets or alleys of the City at a greater rate of speed than that fixed by the City Council by ordinance or by posted speed limit signs. In areas in which a speed limit is not posted or otherwise set by ordinance, the speed limit on all streets or alleys of the City shall be 20 miles per hour.

And that Martin Code 4-1-23 TRUCK SPEED AND LOAD ON MAIN STREET shall be repealed. This Ordinance shall be in force from and after its passage and publication as required by law.
