The Martin City Council met in Regular Session on Wednesday, September 8, 2025 at 5:30 p.m. in the Library Community Room at 101 Main Street.

Mayor Gary Rayhill called the meeting to order with council members Tootie Moffitt, Warren Peterson, Joyce Wilson, Janelle Haynes, Randy Kocourek and Doug Lucero present. Absent, none.

Approval of Agenda: Lucero moved to approve the agenda with flexibility. Kocourek seconded the motion. All in favor, motion carried.

Minutes: Lucero moved to approve the minutes from the August 13th meeting. Peterson seconded the motion, all voting aye, motion carried.

They were also able to donate \$1100 to BC Senior Citizens from the food sales during Summer Fest. They also added an extra \$500 To make it \$1600.

Law: There were 228 calls for service, 129 of those were in Martin. 36 traffic tickets in Martin, 4 ordinance tickets issued and 18 arrests with 1 of those for felonies.

Hay Ground Lease: Kocourek moved to advertise the airport hay ground for lease as the current lease ends in November. Lucero seconded the motion, all voting aye, motion carried.

Clean Up Month: Wilson moved to have October as Free Clean-up month for city residents. Peterson seconded the motion, all voting aye, motion carried.

Cozad Property: County Commissioner Jay Yohner addressed the Council concerning the Cozad property. He said that the county would give their portion of the property to the city if the city would develop it by putting housing on it. After some discussion Lucero moved to invite the Black Hills Council of Local Governments to the October meeting to explain the options the city would have and how they could help. Peterson seconded the motion, all voting aye, motion carried.

Building Permits: Kocourek moved to approve the building permit for Gene Noel. He is putting up a portable car port at 208 West Bennet Ave. Peterson seconded the motion, all voting aye, motion carried.

Past due Water Bills: A motion to handle the past due water bills as usual was entered by Lucero and seconded by Peterson. All voting aye, motion carried.

Code Enforcement: Earl Adair addressed the council concerning the letter he received from the city's code enforcement person. He would like an extension on the deadline of September 19th. He told the council that there was a group of people coming from Mitchell to help him work on the house at 305 Stover Street. Lucero moved to extend the deadline to October 8th. Peterson seconded the motion, all voting aye, motion carried.

409 Dorothy: A discussion was held on the property at 409 Dorothy St. This property has recently been sold. Lucero moved to have Code Enforcement Specialists notify the new owner of the property of what needs to be done to be in compliance with city ordinances. Kocourek seconded the motion, all voting aye, motion carried.

Adjournment: As there was no further business to come before the council at this time, motion to adjourn was entered by Kocourek.
